NOTIFICATION

*New Delhi, the 11th February 1970*

**S.O. 614.**—In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following rules further to amend the Government of India (Allocation of Business) Rules, 1961, namely:—

1. **Short title and commencement.**—(1) These rules may be called the Government of India (Allocation of Business) (Seventy-Seventh Amendment) Rules, 1970.

(2) They shall come into force at once.

2. In the Second Schedule to the Government of India (Allocation of Business) Rules, 1961,—

(a) under the heading "Ministry of Food, Agriculture, Community Development and Cooperation", under sub-heading "A. Department of Agriculture", after entry 38, the following entry shall be inserted, namely:—

"38A. Administration of Insecticides Act, 1968.";

(b) under the heading "Ministry of Law", under sub-heading "B. Legislative Department", for entry 3, the following entry shall be substituted, namely:—

"3. (a) Publication of Central Acts, Ordinances and Regulations;

- (b) Publication of authorised translations in Hindi of Central Acts, Ordinances, Orders, Rules, Regulations and bye-laws referred to in section 5(1) of the Official Languages Act, 1963 (19 of 1963).";
- (c) under the heading "Ministry of Petroleum and Chemicals and Mines & Metals", under sub-heading "B. Department of Chemicals", for entry 12, the following entry shall be substituted, namely:—
- "12. Insecticides (excluding the administration of the Insecticides Act, 1968)."; and
- (d) under the heading "Department of Atomic Energy", for entry 10, the following entry shall be substituted, namely:—
- "10. All matters relating to the Tata Memorial Centre, Bombay."
