NOTIFICATION

New Delhi, the 26th June 1970

S.O. 2247.—In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following rules further to amend the Government of India (Allocation of Business) Rules, 1961, namely:—

1. **Short title and commencement.**—(1) These rules may be called the Government of India (Allocation of Business) (Eightythird Amendment) Rules, 1970.

(2) They shall come into force at once.

2. In the First Schedule to the Government of India (Allocation of Business) Rules, 1961, for entry 23 the following entry shall be substituted, namely:—

“23. Cabinet Secretariat:

(i) Department of Cabinet Affairs.

(ii) Department of Electronics.

(iii) Department of Scientific and Industrial Research.

(iv) Department of Personnel.

(v) Department of Statistics.”

3. In the Second Schedule to the Government of India (Allocation of Business) Rules, 1961,

(a) under the heading “Ministry of Defence”, under the sub-heading “Department of Defence Supplies”, entry 21A shall be omitted;

- (b) under the heading "Ministry of Education and Youth Services",—
- (i) in entry 51, after the words "atomic energy", the words "or grants to institutions, associations or bodies with which any other department is concerned" shall be inserted;
 - (ii) entry 91 shall be omitted;
- (c) under the heading "Ministry of Industrial Development, Internal Trade and Company Affairs", under the sub-heading "A. Department of Industrial Development" under section "III. Industries and Industrial and Technical Development" after entry 12 the following entry shall be inserted, namely:—
- "12A. Administration of the Petroleum Act, 1934, and the rules made thereunder.";
- (d) under the heading, "Ministry of Petroleum and Chemicals and Mines and Metals", under the sub-heading "A. Department of Petroleum", entry 6 shall be omitted;
- (e) under the heading "Cabinet Secretariat",—
- (i) after the sub-heading "A. Department of Cabinet Affairs", and the entries thereunder the following shall be inserted, namely:—
 - "B. Department of Electronics Development of Electronics and coordination amongst its various users.
 - C. Department of Scientific and Industrial Research. All matters relating to the Council of Scientific and Industrial Research.
 - D. Department of Personnel";
 - (ii) for the sub-heading "B. Department of Statistics", the sub-heading "E. Department of Statistics" shall be substituted.
