N O T I F I C A T I O N

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following rules further to amend the Government of India (Allocation of Business) Rules, 1961, namely:-

1. (1) These rules may be called the Government of India (Allocation of Business) (Ninety-eighth Amendment) Rules, 1973.

(2) They shall come into force at once.

2. In the Second Schedule to the Government of India (Allocation of Business) Rules, 1961, --

(A) under the heading "MINISTRY OF AGRICULTURE (KRISHI MANTRALAYA)",

(i) under sub-heading "C. DEPARTMENT OF COMMUNITY DEVELOPMENT (SAMUDAYIK VIKAS VIBHAG)",

(a) for entry 1, the following entry shall be substituted, namely:-

"1. Rural Community Development Programme including programmes of Rural Works and Local Development Works, construction of wells for Rural drinking water, other than piped water supply.";

(b) after entry 4, the following entry shall be inserted, namely:-

"5. Matters relating to Bharat Sevak Samaj.";

(ii) under sub-heading "D. DEPARTMENT OF COOPERATION (SAHKARITA VIBHAG)", after entry 6, the following

entry shall be inserted, namely:-

"7. Consumer Cooperatives.";

- (B) under the heading "MINISTRY OF COMMERCE(VANIJYA MANTRALAYA)"; under sub-heading "B. DEPARTMENT OF INTERNAL TRADE (AANTRIK VYAPAR VIBHAG)", item "III. Village Industries" and entries 8 and 9 thereunder shall be omitted.;
- (C) under the heading "MINISTRY OF EDUCATION AND SOCIAL WELFARE(SHIKSHA AUR SAMAJ KALYAN MANTRALAYA)", under sub-heading "A. DEPARTMENT OF EDUCATION(SHIKSHA VIBHAG)";
- (i) for entry 5, the following entry shall be substituted, namely:-
- "5. University education; Central Universities; Rural higher education; Foreign Aid Programmes relating to Higher Education, Technical Education, Planning and Development of School Education.";
- (ii) after entry 12, the following entries shall be inserted, namely:-
- "12A. Production of University level text-books in Regional Languages.
- 12B. The Copyright Act, 1957 and International Conventions on Copyright.";
- (iii) entries 29, 31, 46 and 49 shall be omitted.;
- (iv) after entry 53, the following entry shall be inserted, namely:-
- "53A. International Students' Houses in India and abroad.";
- (D) the heading "MINISTRY OF FOREIGN TRADE(VIDESH VYAPAR MANTRALAYA)" and the entries thereunder, shall be omitted and shall be deemed to have been omitted with effect from the 7th February, 1973.;

(E) under the heading "MINISTRY OF HEALTH AND FAMILY PLANNING(SWASTHYA AUR PARIVAR NIYOJAN MANTRALAYA)", under sub-heading "B. DEPARTMENT OF FAMILY PLANNING (PARIVAR NIYOJAN VIBHAG)",

(i) for entry 3, the following entry shall be substituted, namely:-

"3. Organisation and direction of education, training and research in all aspects of family planning, including higher training abroad.";

(ii) for entry 7, the following entry shall be substituted, namely:-

"7. International Institute of Population Studies, Bombay.";

(iii) after entry 7, the following entries shall be inserted, namely:-

"8. Development and production of audio-visual aids, extension education and information in relation to population and family planning.

9. Grant-in-aid for the family planning programme to voluntary organisations and local bodies.

10. Hindustan Latex Ltd.

11. National Institute of Family Planning, New Delhi.";

(F) under the heading "MINISTRY OF INDUSTRIAL DEVELOPMENT (AUDYOGIK VIKAS MANTRALAYA)", after item "VI. Materials Planning" and the entries thereunder, the following item and entries shall be inserted, namely:-

"VIA. Village Industries

32A. Co-ordination and development of Village Industries including Khadi.

32B. Ambar Charkha.";

(G) under the heading "MINISTRY OF LAW, JUSTICE AND COMPANY AFFAIRS(VIDHI, NYAYA AUR KAMPANI KARYA MANTRALAYA)", under sub-heading "D. DEPARTMENT OF COMPANY AFFAIRS (KAMPANI KARYA VIBHAG)", after entry 1, the following entry shall be inserted, namely:-

"1A. Administration of the Companies(Donations to National Funds) Act, 1951.";

(H) under the heading "MINISTRY OF STEEL AND MINES(ISPAT AUR KHAN MANTRALAYA)",

(i) under sub-heading "A. DEPARTMENT OF STEEL(ISPAT VIBHAG)", for the existing entries, the following entries shall be substituted, namely:-

1. Steel plants in the public and private sectors, the rerolling industry and ferro-alloys including all future development.
2. Development of iron ore mines in the public sector.
3. Development of other ore mines and coal washeries and mineral processing for the steel plants.
4. Production, distribution, prices, imports and exports of iron and steel and ferro-alloys.
5. Planning, development and control of, and assistance to, all iron and steel industries.
6. Production, Supply, distribution and price of coking coal.
7. Production, Supply, pricing and distribution of iron ore, manganese ore, limestone, sillimanite, kyanite and other minerals and alloys used in the steel industry, excluding grant of mining leases or matters connected therewith.
8. The Steel Authority of India, Limited and its subsidiaries.

9. Matters relating to the following undertakings, namely:-

- (1) The Mysore Iron and Steel Company Limited.
- (2) The Bolani Ores (India) Limited.
- (3) The Manganese Ore (India) Limited.
- (4) The Metals Scrap Trading Corporation.

10. Other Public Sector Enterprises or undertakings falling under the subjects included in this list except such as are specifically allotted to any other Department.

11. All Attached or Subordinate Offices or other organisations concerned with any of the subjects specified in this list.";

(ii) under sub-heading "B. DEPARTMENT OF MINES(KHAN VIBHAG)", for the existing entries, the following entries shall be substituted, namely:-

1. Production, Supply, distribution and prices of coal other than coking coal.
2. Exploration and development of lignite deposits in India.
3. Setting up of synthetic oil plant based on coal and low temperature carbonization plants for the production of smokeless domestic coal.
4. Administration of the Coal Mines (Conservation and Safety) Act, 1952.
5. Development and operation of coal washeries other than those for which the Department of Steel (Ispat Vibhag) is responsible.
6. Administration of the Coal Bearing Areas (Acquisition and Development) Act, 1957.
7. Regulation of mines and minerals development under the Mines and Minerals(Regulation and Development) Act, 1957, and other Union laws including questions concerning various States and incidental business in respect of these.
8. All other metals and minerals not specifically allotted to any other Department, such as aluminium, zinc, copper, gold, diamonds, lead and nickel.

9. Planning, development and control of, and assistance to, all industries dealt with by the Department.
10. Geological Survey of India.
11. Indian Bureau of Mines.
12. All other attached or subordinate offices or other organisations concerned with any of the subjects specified in this list.
13. Matters relating to the following undertakings --
  - (i) The Singareni Collieries Company Limited.
  - (ii) The Sikkim Mining Corporation Limited.
14. Public Sector enterprises and undertakings falling under the subjects included in this list except such as are specifically allotted to any other Department.";

(I) under the heading "DEPARTMENT OF CULTURE(SANSKRITI VIBHAG)",

(i) entry 7 shall be omitted.;

(ii) for entry 21, the following entry shall be substituted, namely:-

"21. Schemes for grant of financial assistance to voluntary organisations for promotion of Modern Indian Languages.";

(iii) entries 26 and 36 shall be omitted.;

(iv) after entry 39, the following entries shall be inserted, namely:-

"39A. Observance of Centenaries and Anniversaries of important personalities.

39B. Publication, information and statistics relating to subjects dealt with by this Department.

39C. International Congress of Orientalists.

39D. Anthropological Survey of India.

39E. National Archives of India.";

(J) under the heading "DEPARTMENT OF SCIENCE AND TECHNOLOGY(VIGYAN AUR PRODYOGIKI VIBHAG)", after entry 14, the following entry shall be inserted, namely:-

"14A. Indian National Scientific Documentation Centre,";

(K) under the heading "DEPARTMENT OF SUPPLY(POORTI VIBHAG)", for entry 4, the following entry shall be substituted, namely:-

"4. Administration of —

- (a) Directorate General of Supplies and Disposals;
- (b) Office of the Chief Pay and Accounts Officer, New Delhi;
- (c) National Test House, Alipore, Calcutta;
- (d) India Supply Mission, the United Kingdom;
- (e) India Supply Mission, the U.S.A."
