N O T I F I C A T I O N

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following rules further to amend the Government of India (Allocation of Business) Rules, 1961, namely:-

1. (1) These rules may be called the Government of India (Allocation of Business) (One hundred and forty-third Amendment) Rules, 1980.

(2) They shall come into force at once.

2. In the Second Schedule to the Government of India (Allocation of Business) Rules, 1961, (hereinafter referred to as the said rules):-

(a) under the heading "MINISTRY OF AGRICULTURE AND IRRIGATION (KRISHI AUR SINCHAI MANTRALAYA)", under the sub-heading "A. DEPARTMENT OF AGRICULTURE AND COOPERATION (KRISHI AUR SAHKARITA VIBHAG)", entries 22, 23, 28, 29 and 33 shall be omitted;

(b) under the heading "MINISTRY OF COMMERCE AND CIVIL SUPPLIES (VANIJYA AUR NAGRIK POORTI MANTRALAYA)",-

(1) under the sub-heading "A. DEPARTMENT OF COMMERCE (VANIJYA VIBHAG)", -

(i) in entry 11, item (f) shall be omitted;

(ii) in entry 15, item (vi) shall be omitted;

(2) under the sub-heading "C. DEPARTMENT OF TEXTILES (VASTR VIBHAG)", after entry 18, the following entries shall be inserted, namely:-

" 19. Development and expansion of export production in relation to textiles, woollens, handlooms, ready-made garments, silk and cellulosic fibres, jute and jute products and handicrafts;

20. Handicrafts and Handlooms Export Corporation ;

(c) under the heading "MINISTRY OF RURAL RECONSTRUCTION (GRAMIN PUNARNIRMAN MANTRALAYA)", after entry 2, the following entries shall be inserted, namely :-

- " 2A. Administration of the Land Acquisition Act, 1894, and other matters relating to acquisition of land for purposes of the Union.
- 2B. Recovery of claims in a State in respect of taxes and other public demands, including arrears of land revenue and sums recoverable as such arrears, arising outside that State.
- 2C. Land, that is to say collection of rents, transfer and alienation of land and improvement and agricultural loans, excluding acquisition of non-agricultural land or buildings, town planning improvements.
- 2D. Land revenue, including the assessment and collection of revenue, survey for revenue purposes, alienation of revenues.
- 2E. Duties in respect of succession to agricultural land."
