S.O. 3339-A.—The following Order made by the President on November 3, 1962, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes, with immediate effect, the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules--

(A) in the First Schedule.

for entry 3, the following entry shall be substituted, namely:

"Ministry of Defence

(with a Department of Deferce Production within the Ministry)."

(B) in the Second Schedule,

for the entries under the heading "Ministry of Defence", the entries given in the Appendix to this Order shall be substituted.

APPENDIX

MINISTRY OF DEFENCE

- Defence of India and every part thereof including preparation for defence and all such acts as may be conducive in times of war to its prosecution, and after its termination to effective demobilisation.
- 2. The Armed Forces of the Union, namely; Army; Navy and Air Force.
- 3. The Reserves of the Army, Navy and Air Force.
- 4. The Territorial Army and the Auxiliary Air Force.
- The National Cadet Corps, the Auxiliary Cadet Corps and the Lok Sahayak Sena.
- 6. Works relating to Army, Navy, Air Force and Ordnance Factories.

- 7. Remounts, Veterinary and Farms Organisation.
- 8. Canteen Stores Department (India),
- 9. Civilian Services paid from Defence Estimates.
- 10. Hydrographic surveys and preparation of navigational charts.
- 11. Formation of Cantonments, delimitation/excision of Cantonment areas, local self-government in such areas, the constitution and powers within such areas of Cantonment Boards and authorities and the regulation of house accommodation (including the control of rents) in such areas.
- Acquisition, requisitioning, custody and refinquishment of land and property for defence purposes. Eviction of unauthorised occupants from defence land and property.
- 13. Matters relating to ex-Servicemen including pensioners.
