NOTIFICATION

New Delhi, the 16th November, 1962

S.O. 3487.—The following Order made by the President on November 15, 1962, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of Article 77 of the Constitution, the President hereby makes, with immediate effect, the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules-

- (A) in the First Schedule,
 - (a) for the existing entry 3A, the following entry shall be substituted, namely:--
 - "3A. Ministry of Economic and Defence Co-ordination:
 - (i) Department of Supply
 - (ii) Department of Co-ordination
 - (iii) Department of Technical Development";
 - (b) for the existing entry 19, the following entry shall be substituted, namely:—
 - "19. Ministry of Works and Housing;
 - (i) Department of Works and Housing
 - (ii) Department of Rehabilitation":
- (B) in the Second Schedule,
 - (a) under the heading "Ministry of Commerce and Industry" and subheading "B. Department of Industry", sub-entry (i) under entry 23(a) shall be omitted;
 - (d) for the existing heading "Ministry of Works, Housing and Supply" and Defence Co-ordination", the entries in the Appendix to this Order shall be substituted;

- (c) under the heading "Ministry of Steel and Heavy Industries" and subheading "B. Department of Heavy Industries", entry 12 shall be omitted;
- (d) for the existing heading "Ministry of Works, Housing and Supply" and sub-heading "A. Department of Works, Housing and Supply" the following shall be substituted, namely:—

"Ministry of Works and Housing

- A. Department of Works and Housing"; and
- (e) entries 18, 19 and 20 and sub-entries (e) to (h) of entry, 23 under the existing heading "Ministry of Works, Housing and Supply" and subheading "A. Department of Works, Housing and Supply" shall be omitted.

APPENDIX

MINISTRY OF ECONOMIC AND DEFENCE CO-ORDINATION

- A. Department of Supply:
- 1. Purchase, inspection and shipment of stores for the Central Government other than the items the purchase, inspection and shipment of which are delegated to other authorities by a general or special order.
 - 2. Disposal of surplus stores.
- 3. Residual work of supply and disposal relating to the late war organisations including the Directorate General, Aircraft including Civil Maintenance Units, and Directorate General, Ship Repairs.
 - 4. Administration of:
 - (a) Directorate General of Supplies and Disposals;
 - (b) Government Test House, Alipore, Calcutta;
 - (c) India Store Department, the United Kingdom;
 - (d) India Supply Mission, the U.S.A.
- B. Department of Co-ordination:
 - 1. Co-ordination of civil and defence production and supplies.
- 2. Such other subjects as may be assigned by the Prime Minister from time to time.
- C. Department of Technical Development:
 - 1. The Development Wing.
