NOTIFICATION

*New Delhi, the 2nd September 1963*

**S.O. 2517.**—The following Order made by the President on September 1, 1963, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes, with immediate effect, the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules—

- (A) in the First Schedule,
- (a) entry 3 shall be omitted;
  - (b) entries 4, 5, 6, 7, 8, 9 and 9A shall be renumbered as 3, 4, 5, 6, 7, 8 and 9 respectively;
  - (c) for entry 18 the following entry shall be substituted, namely:—  
“18. Ministry of Transport.”;
  - (d) after entry 21, the following entries shall be inserted, namely:—  
“22. Department of Posts and Telegraphs  
23. Department of Supply  
24. Department of Technical Development”; and
  - (e) the existing entries 22, 23, 24 and 25 shall be renumbered as 25, 26, 27 and 28 respectively;
- (B) in the Second Schedule,
- (a) the heading “Ministry of Economic & Defence Co-ordination” and the entries under that heading shall be omitted;
  - (b) for the heading “Ministry of Transport and Communications” and the entries under that heading, the following heading and entries shall be substituted, namely:—  
“Ministry of Transport” and the entries given in Appendix I to this Order;
  - (c) after the entries under the heading “Department of Parliamentary Affairs” and before the heading “Cabinet Secretariat”, the following headings and entries shall be inserted, namely:—

- (i) "Department of Posts and Telegraphs" and entries given in Appendix II to this Order;
- (ii) "Department of Supply" and entries given in Appendix III to this Order; and
- (iii) "Department of Technical Development" and entries given in Appendix IV to this Order.

## APPENDIX 'I'

## MINISTRY OF TRANSPORT

I. The following subjects which fall within List I of the Seventh Schedule to the Constitution of India:—

1. Maritime shipping and navigation; provision of education and training for the mercantile marine.
  2. Lighthouses and lightships.
  3. Major ports i.e., the ports of Calcutta, Bombay, Madras, Visakhapatnam, Cochin and Kandla.
  4. Compulsory insurance of motor vehicles.
  5. Administration of the Road Transport Corporation Act, 1950.
  6. Highways declared by or under law made by Parliament to be national highways.
  7. Shipping and navigation including carriage of passengers and goods on inland waterways declared by Parliament by law to be National waterways as regards mechanically propelled vessels; the rule of the road on such waterways.
  8. Ship building (Public sector).
- II. In respect of the Union Territories:—
9. Roads other than national highways.
  10. Tramways within municipal limits.
  11. Inland waterways and traffic thereon.
  12. Administration of the Motor Vehicles Act, 1939, and taxation of motor vehicles.
  13. Vehicles other than mechanically propelled vehicles.
- III. Other subjects not included under the preceding headings:—
14. Central Road Fund.
  15. Coordination and research pertaining to road works.
  16. Road works financed in whole or in part by the Central Government, including road works in Sikkim and the tribal areas of Assam specified in parts A and B of the table appended to para 20 of the Sixth Schedule to the Constitution.
  17. Motor vehicles legislation.
  18. Legislation relating to shipping and navigation on inland waterways as regards mechanically propelled vessels and the carriage of passengers and goods on inland waterways.
  19. Tourist traffic development.
  20. Planning of road and inland waterways transport.
  21. Promotion of Transport Cooperative in the field of motor transport and inland water transport.
  22. Development of township of Gandhidham.
  23. Legislation relating to and co-ordination of the development of minor ports.

24. Centralised arrangements for the servicing and repairs of staff cars belonging to the Central Government except those under the control and use of the Ministry of Railways and the Department of Atomic Energy.
25. Implementation of treaties and agreements relating to matters specified in entries 26 to 30 below.
26. Meteorological Organisation.
27. Aircraft and air navigation; provision of aerodromes; regulation and organisation of air traffic and of aerodromes (excepting sanitary control of air navigation).
28. Beacons and other provisions for the safety of aircraft.
29. Carriage of passengers and goods by air.
30. Corporations established under the Air Corporations Act, 1953.
31. Offences against laws with respect to any of the matters specified in entries 26 to 30 above.
32. Inquiries and statistics for the purpose of any of the matters specified in entries 26 to 30 above.
33. Fees in respect of any of the matters specified in entries 26 to 30 above but not including fees taken in any court.
34. Railway Inspectorate.

## APPENDIX 'II'

## DEPARTMENT OF POSTS &amp; TELEGRAPHS

1. Implementation of treaties and agreements relating to matters dealt within the Department of Posts and Telegraphs, with other countries.
2. Posts and Telegraphs, including Telephones, Wireless and other like forms of communications, Post Office Savings Bank (Administration), Post Office Certificates (Administration) and Post Office Life Insurance Fund (Administration).
3. Indian Telephone Industries, Bangalore and the Hindustan Teleprinters Ltd., Madras.
4. Offences against laws with respect to any of the matters in this list.
5. Inquiries and statistics for the purpose of any of the matters in this list.
6. Fees in respect of any of the matters in this list but not including fees taken in any court.

## APPENDIX 'III'

## DEPARTMENT OF SUPPLY

1. Purchase, inspection and shipment of stores for the Central Government other than the items the purchase, inspection and shipment of which are delegated to other authorities by a general or special order.
2. Disposal of surplus stores.
3. Residual work of supply and disposal relating to the late war organisations including the Directorate General, Aircraft, including Civil Maintenance Units, and Directorate General, Ship Repairs.
4. Administration of:
  - (a) Directorate General of Supplies and Disposals;
  - (b) Government Test House, Alipore, Calcutta;
  - (c) India Store Department, the United Kingdom;
  - (d) India Supply Mission, the U.S.A.
