NOTIFICATION

New Delhi, the 2nd March 1964

S.O. 736.—The following Order made by the President on February 29, 1964, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following amendments in the Government of India (Allocation of Business) Rules 1961, namely:—

In the said Rules—

(A) in the First Schedule, for entry 3. the following entry shall be substituted, namely:—

“3. Ministry of Education”; and

(B) in the Second Schedule, under the heading, “Ministry of Education”, for sub-heading “A. Department of Education” and the entries thereunder, and for sub-heading “B. Department of Science” and the entries thereunder, the entries as given in the Appendix to this Order shall be substituted.
