NOTIFICATION

New Delhi, the 16th April 1964

S.O. 1378.—The following Order made by the President on April 15, 1964, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes, with effect from the 16th April, 1964, the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules—

(A) in the First Schedule,

(a) after entry 15, the following entry shall be inserted, namely:

“15A. Ministry of Rehabilitation.”;

(b) for entry 18, the following entry shall be substituted, namely:

“18. Ministry of Works & Housing.”;

(B) in the Second Schedule,

(a) under the heading “Ministry of Home Affairs”, in the foot-note after the entries under that heading, for the words “Department of Rehabilitation”, the following words shall be substituted, namely:

“Ministry of Rehabilitation”;

(b) after the entries under the heading “Ministry of Railways” and before the heading “Ministry of Steel, Mines & Heavy Engineering”, the following heading and entries shall be inserted, namely:

“Ministry of Rehabilitation”;

and the entries given in Appendix I to this Order; and

(c) for the heading “Ministry of Works, Housing & Rehabilitation” and the entries under that heading, the following heading and entries shall be substituted, namely:

“Ministry of Works & Housing” and the entries given in Appendix II to this Order.

APPENDIX I

MINISTRY OF REHABILITATION

- *1. Camps for displaced persons from East Pakistan.
- *2. Relief for displaced persons (including supplies of medicine, food, clothing and other necessities).
- *3. Rehabilitation of displaced persons.
- *4. Assistance to displaced persons from East Pakistan in setting up business or industry including provision of settlement on land.
- *5. Housing of displaced persons.
- *6. Setting up of new industries in displaced persons' townships and colonies and places where there are heavy concentrations of displaced persons from East Pakistan for providing employment.
- *7. Matters relating to grants-in-aid to educational, medical and cultural institutions.
- *8. Training and employment of displaced persons from East Pakistan.
9. Management of evacuee property.
10. Evacuee Interest (Separation) Act, 1951.
11. The Transfer of Evacuee Deposits Act, 1954.
12. Displaced Persons (Debts Adjustment) Act, 1951.
13. All negotiations concerning the evacuee property—movable and immovable—of displaced persons from Pakistan left behind by them in Pakistan and restoration of movable property including fire-arms, lockers, safe-deposits, etc.
14. Verification of displaced persons' claims for the immovable property left in West Pakistan.
15. Settlement of verified claims and payment of rehabilitation grants to displaced persons in respect of immovable property left by them in West Pakistan.
16. Valuation and disposal of Government built and evacuee properties.
17. Verification and payment of claims of displaced Government servants of undivided Provinces and servants of States and local bodies in respect of pensions, provident funds, leave salary and security deposits.
18. Rehabilitation of migrants from Pakistan-occupied areas of Jammu & Kashmir.
19. Rehabilitation of Muslim migrants who have returned from East Pakistan to west Bengal under the Nehru-Liaquat Pact; rehabilitation of Muslims internally displaced in West Bengal at the time of communal disturbances on the partition of the country; and restoration of mosques and other places of religious worship to Muslims in West Bengal.
20. Dandakaranya Scheme—Integrated development of Dandakaranya area for the rehabilitation of East Pakistan displaced persons and welfare of tribals.
21. Development of such special areas as may be indicated by the Prime Minister from time to time.
22. All Attached or Subordinate Offices or other organisations concerned with any of the subjects specified in this list.

*1. As regards rehabilitation matters in States, the Central Government is concerned mainly with questions of policy in respect of the subjects marked with an asterisk and is not directly concerned with administrative and executive details which are the functions of the State Governments, except where camps, rehabilitation colonies, educational institutions, training centres, etc. are directly administered by the Central Government.

2. The administrative control in regard to the items marked with an asterisk, in so far as they relate to the displaced persons from East Pakistan in Tripura, vests in the Ministry of Home Affairs.

APPENDIX II

MINISTRY OF WORKS & HOUSING

1. Property of the Union (not being railway, naval, military or air force works or being the property of the Department of Atomic Energy) except (i) buildings, the construction of which has been financed otherwise than from the civil works budget and (ii) buildings, the control of which has at the time of construction or subsequently, been permanently made over by the Ministry of Works & Housing to another Ministry.
2. All Government Civil works and buildings including those of Union Territories excluding roads and excluding works executed by or buildings belonging to the Railways and the Department of Atomic Energy.
3. Horticultural operations.
4. Indian Service of Engineers.
5. Development of Government colonies in Delhi.
6. Allotment of Government lands in Delhi.
7. Administration of Government estates under the control of the Ministry of Works & Housing at Delhi, Bombay, Calcutta, Simla, Nagpur, etc. Move of offices outside Delhi including the satellite townships around Delhi; deconcentration of offices from Bombay and Calcutta; location of new offices in Delhi, Calcutta, Bombay and Simla.
8. Allotment of accommodation in Vigyan Bhavan.
9. Administration of the Requisitioning and Acquisition of Immovable Property Act, 1952.
10. Control and administration of Hotel Janpath, New Delhi, Grand Hotel, Simla and Government Hostels.
11. Administration of Delhi Hotels (Control of Accommodation) Act, 1949.
12. The Public Premises (Eviction of Unauthorised Occupants) Act, 1958.
13. Administration of Rehabilitation Markets—Raisina Road Market; Sarojini Market, Sarojini Nagar; New Central Market, Connaught Circus; Kamla Market and Pleasure Garden Market.
14. Formulation of housing policy and programme. Review of the implementation of the Plan Schemes. Collection and dissemination of data on housing, building materials and building techniques. General measures for reduction of building costs. International cooperation and technical assistance in housing.
15. Stationery and printing for the Government of India including official publications.
16. Administration of the Indian Boilers Act and the Regulations made thereunder; Central Boilers Board.
17. Explosives, administration of the Indian Explosives Act, 1884, the Petroleum Act, 1934, and the Rules made thereunder; but not the Explosive Substances Act.
18. The Ashoka Hotels Ltd., New Delhi.
19. All Attached or Subordinate Offices or other organisations concerned with any of the subjects specified in this list.
20. Public sector projects falling under the subjects included in this list except such projects as are specifically allotted to any other Department.
