NOTIFICATION.

New Delhi, the 21st April, 1965

S.O. 1319—The following Order made by the President on April 18, 1965, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules—

1. under the heading "Ministry of Commerce",

(a) after entry 18, the following entry shall be inserted under sub-heading "I. Trade", namely:—

"18A. U.N. Conference on Trade and Development.";

(b) after entry 21, the following entry shall be inserted, namely:—

"21A. Emblems and Names (Prevention of Improper Use) Act, 1950.";

(c) after entry 27, the following entry shall be inserted under sub-heading "V. Plantation Industries", namely:—

"27A. Cardamom.";

(d) for entry 41, the following entry shall be substituted, namely:—

"41. All Attached or Subordinate Offices or other organisations concerned with any of the subjects specified in this list, including:—

- (i) Chief Controller of Imports and Exports, New Delhi.
- (ii) Textile Commissioner, Bombay.
- (iii) Jute Commissioner, Calcutta.
- (iv) Forward Markets Commission, Bombay.
- (v) Tariff Commission, Bombay.
- (vi) Director General of Commercial Intelligence and Statistics, Calcutta
- (vii) Commodity Boards viz. Tea Board, Coffee Board, Rubber Board, Coir Board, Silk Board."

(e) for entry 42, the following entry shall be substituted, namely:—

"42. State Undertakings and Government Corporations relatable to subjects specified in this list, including:—

- (i) The State Trading Corporation Ltd.
- (ii) The Minerals and Metals Trading Corporation Ltd.
- (iii) The Export Credit and Guarantee Corporation Ltd.;"

2. under the heading "Ministry of Finance",

(a) under sub-heading, "A. Department of Economic Affairs", after entry 26, the following entry shall be inserted, namely:—

"26A. Grants to the Indian Institute of Public Administration.;"

(b) under sub-heading "D. Department of Coordination", entry 7 shall be omitted.;

3. under the heading "Ministry of Health", after entry 56, the following entry shall be inserted, namely:—

"57. All India Institute of Physical Medicine and Rehabilitation, Bombay."

4. under the heading "Ministry of Rehabilitation", after entry 21, the following entry shall be inserted, namely:—

"21A. Relief and Rehabilitation measures for Indian nationals repatriated from Burma and Ceylon.;" and

5. under the heading "Department of Social Security", and sub-heading, "A. Social Security", entry 6 shall be omitted.
