NOTIFICATION

New Delhi, the 3rd August 1965

S.O. 2494.—The following Order made by the President on August 3 1965, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules, in the Second Schedule,

1. under the heading, "Ministry of Home Affairs",

(a) after entry 32, the following entry shall be inserted, namely:—

"32A. According of sanction for the prosecution of any person for any offence investigated into by the Delhi Special Police Establishment, where such sanction is required to be accorded by the Central Government.

NOTE.—Sanction for the prosecution of any person for any offence not investigated into by the Delhi Special Police Establishment, shall be accorded by the Administrative Ministry, where such sanction is required to be accorded by the Central Government."

(b) under 'Part III—Additional subjects with regard to Union Territories'

(i) under sub-heading '(b) (ii) For the Union Territory of Andaman & Nicobar Islands', for entry 123, the following entry shall be substituted namely:—

"123. All matters except:

(a) forests, education, road and bridge works and ferries thereon; and

(b) organisation and maintenance of mainland islands and inter-island shipping services;" and

(ii) under sub-heading '(b) (iii) For the Union Territories of Laccadive, Minicoy and Amindivi Islands', for entry 124, the following entry shall be substituted, namely:—

"124. All matters relating to these islands except organisation and maintenance of mainland-islands and inter-islands shipping services."

2. under the heading, "Ministry of Industry & Supply", and sub-heading, "A. Department of Industry", after entry 9 under section "III. Industries and Industrial Development", the following entry shall be inserted, namely:—

"9A. Administration of the Indian Boilers Act and the Regulations made thereunder; Central Boilers Board."

3. under the heading "Ministry of Transport", after entry 13, the following sub-heading and entry shall be inserted, namely:—

"IIA. In respect of the Union Territories of Andaman and Nicobar Islands and Laccadive, Minicoy and Amindivi Islands:

13A. Organisation and maintenance of mainland-islands and inter-island shipping services;" and

4. under the heading, "Ministry of Works & Housing", entry 16 shall be omitted.
