NOTIFICATION

New Delhi, the 2nd February 1966

S.O. 426.—The following Order made by the President on February 1, 1966, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes, with immediate effect, the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules, in the Second Schedule,

(1) under the heading "Ministry of Education", after entry 70, the following entry shall be inserted, namely:—

"70A. Revision of Gazetteers.";

(2) under the heading "Ministry of Finance", under sub-heading "A. Department of Economic Affairs", after entry 31 in section "VI. Corporations", the following section and entries thereunder shall be inserted, namely:—

"VIA. Stock Exchanges

31A. Administration of Securities Contracts (Regulation) Act, 1956.

31B. Regulation of Stock Exchanges."

- (3) under the heading "Ministry of Irrigation and Power", after entry 27, the following entries shall be added, namely:—
- "28. The Muslim Wakfs Act, 1954.
29. Work in respect of Wakf properties under the Administration of Evacuee Property Act, 1950.
30. Administration of Dargah Khawaja Saheb Act, 1955."
- (4) under the heading "Ministry of Labour, Employment and Rehabilitation", under sub-heading "A. Department of Labour and Employment",
- (a) after entry 5 in 'Part II—Concurrent Subjects', the following entry shall be inserted, namely:—
- "5A. Unemployment insurance."; and
- (b) after entry 25 in 'Part V—Miscellaneous Business', the following entry shall be inserted, namely:—
- "25A. Administration of the Employees' State Insurance Act, the Employees' Provident Funds Act and Coal Mines Provident Fund Act."
- (5) under the heading "Ministry of Law", under sub-heading "C. Department of Company Affairs", entries 2 and 3 shall be omitted;
- (6) under the heading "Ministry of Petroleum and Chemicals", under sub-heading "B. Department of Chemicals", the section "Other Subjects" and all the entries thereunder, namely, entries 18, 19, 21 and 22, shall be omitted; and
- (7) under the heading "Department of Social Welfare"
- (a) entry 12 shall be omitted; and
- (b) for entry 13, the following entry shall be substituted namely:—
- "13. Social security measures."
