NOTIFICATION

New Delhi, the 30th June 1966

S.O. 2000.—The following Order made by the President on June 29, 1966, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules, in the Second Schedule,

(1) under the heading "Ministry of Health and Family Planning",

(a) under the sub-heading "A. Department of Health", entry 1(xv) shall be omitted;

- (b) under the sub-heading "B. Department of Family Planning", after entry 5, the following entry shall be added, namely:—
- "6. Demographic Training and Research Centre, Bombay.";
- (2) under the heading "Ministry of Home Affairs",
- (a) after entry 14A, the following entries shall be inserted, namely:—
- "14B. Assam Rifles.
14C. Border Security Force.";
- (b) entries 111 and 113 shall be omitted;
- (3) under the heading "Ministry of Industry", under Section "III. Industries and Industrial Development", after entry 10, the following entry shall be inserted, namely:—
- "11. Explosives, administration of the Indian Explosives Act, 1884, and the Rules made thereunder; but not the Explosive Substances Act.";
- (4) under the heading "Ministry of Petroleum and Chemicals", under the sub-heading "A. Department of Petroleum", after entry 5, the following entry shall be inserted, namely:—
- "5A. Administration of the Petroleum Act, 1934, and the Rules made thereunder.";
- (5) under the heading "Ministry of Supply, Technical Development and Materials Planning", and under the sub-heading "A. Department of Supply & Technical Development", in entry 4, for items (b) and (c), the following shall be substituted, namely:—
- "(b) National Test House, Alipore, Calcutta.
(c) India Supply Mission, the United Kingdom.";
- (6) under the heading "Ministry of Works, Housing and Urban Development",
- (a) for entries 14, 15, 16 and 17, the following entries shall be substituted, namely:—
- "14. The Ashoka Hotels Ltd., New Delhi.
15. Urban Development.
16. Town and Country Planning; Matters relating to Calcutta Metropolitan Planning Organisation.
17. Scheme of large scale acquisition, development and disposal of land in Delhi.";
- (b) for entry 20, the following entry shall be substituted, namely:—
- "20. Master Plan of Delhi. Co-ordination of work in respect of the Master Plan and slum clearance in the Union territory of Delhi.";
- (c) for entry 21, the following entry shall be substituted, namely:—
- "21. Administration of the Delhi Development Act, 1957."; and
- (d) after entry 21, the following entry shall be inserted, namely:—
- "21A. The Delhi Rent Control Act, 1958; and evictions in Delhi."
