NOTIFICATION

New Delhi, the 22nd January 1968

S.O. 367.—The following Order made by the President on January 20, 1968, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes, with immediate effect, the following further amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules, in the Second Schedule—

- (1) under the heading, "Ministry of Education", entry 90 relating to 'Central Braille Press, Dehra Dun' shall be omitted;
- (2) under the heading, "Ministry of Food, Agriculture, Community Development and Cooperation",
  - (a) under sub-heading "A. Department of Agriculture", after entry 13 in Part I, the following entry shall be inserted, namely:—

"13A. Sugarcane research and sugarcane development scheme.";
  - (b) under sub-heading "B. Department of Food",
    - (i) in entry 11, the following items shall be omitted, namely:—

"(iv) Indian Institute of Sugarcane Research, Bhadrak, Lucknow.  
(v) Sugarcane Breeding Institute, Coimbatore.";

- (ii) for entry 12, the following entry shall be substituted, namely:—  
 “12. Matters relating to the Development Council for Sugar Industry, New Delhi.”;
- (3) under the heading “Ministry of Industrial Development and Company Affairs”, and sub-heading “A. Department of Industrial Development”, under section “IV. Small Scale Industries”, after entry 26, the following entry shall be inserted, namely:—  
 “25A. Co-ordination of matters relating to Rural Industrialisation.”;
- (4) under the heading “Department of Social Welfare”, after entry 6, the following entry shall be inserted, namely:—  
 “6A. Central Braille Press, Dehra Dun.”; and
- (5) under the heading “Cabinet Secretariat” and sub-heading “B. Department of Statistics”, after entry 4, the following entry shall be inserted, namely:—  
 “5. Computer Centre.”.
