NOTIFICATION

New Delhi, the 12th February 1968

S.O. 656.—The following Order made by the President on February 12, 1968, is published for general information:—

ORDER

In exercise of the powers conferred by clause (3) of article 77 of the Constitution, the President hereby makes, with immediate effect, the following amendments in the Government of India (Allocation of Business) Rules, 1961, namely:—

In the said Rules—

A. in the First Schedule, for entry 7, the following entry shall be substituted, namely:—

“7. Ministry of Health, Family Planning and Urban Development;

(i) Department of Health and Urban Development.

(ii) Department of Family Planning.”;

B. in the Second Schedule,—

(a) for the existing heading “Ministry of Health and Family Planning”, the following heading shall be substituted, namely:—

“Ministry of Health, Family Planning and Urban Development”;

(i) for the existing sub-heading “A. Department of Health”, the following sub-heading shall be substituted, namely:—

“A. Department of Health and Urban Development”;

- (ii) under the sub-heading "A. Department of Health and Urban Development" as so amended, existing entries 66, 67 and 68 shall be renumbered as entries, 73, 74 and 75 respectively; and after entry 65, the following entries shall be inserted, namely:—
- "66. Urban Development including Slum Clearance Schemes.
 - 67. Town and Country Planning; Matters relating to Calcutta Metropolitan Planning Organisation.
 - 68. Scheme of large scale acquisition, development and disposal of land in Delhi.
 - 69. Delhi Development Authority.
 - 70. Improvement Trusts.
 - 71. Master Plan of Delhi. Co-ordination of work in respect of the Master Plan and slum clearance in the Union Territory of Delhi.
 - 72. Administration of the Delhi Development Act, 1957."
- (b) under the heading "Ministry of Works, Housing and Supply", under the sub-heading "A. Department of Works and Housing",
- (i) entries 15, 16, 17, 18, 19, 20 and 21 shall be omitted; and
 - (ii) the existing entries 22, 23, 24, 25 and 26 shall be renumbered as entries 15, 16, 17, 18 and 19 respectively.
